**Basic Requirements.** Dog(s) must be trained, housebroken, vaccinated and must always be on a leash or crated except when in your guest room. Dog(s) must comply with all applicable rules, laws, and regulations, including any health and safety requirements in Walla Walla, Washington. A maximum of two dogs are permitted in any guest room.

**Dog Fee Required.** Guests traveling with dog(s) are responsible for a \$100 non-refundable fee per dog, per stay.

**Unattended Dog.** Dog(s) cannot be left unattended in guestrooms or in vehicles. Housekeeping or other services will not be provided if your dog(s) is left unattended in your room. This is for the safety of your dog(s) and our team members. Please contact the Innkeeper to schedule a convenient time for servicing when you are present.

**Noisy or Disturbing Dog.** Complaints of excessive noise by your dog(s), such as barking, may result in the termination of your stay at Abeja Winery and Inn.

**No Admittance.** Dog(s) are welcome throughout Abeja Winery and Inn with the exception of the Small Barn and select Inn suites. We may amend this list from time to time as necessary. This exclusion does not apply to any ADA certified service animals.

**Paw Treatment.** All our canine guests will receive the following in your room upon arrival and are yours to take with you when you leave: all-natural bee shaped dog biscuit, and disposal bags. I understand the dog bowls have been provided to accommodate my pet and are the property of Abeja Winery and Inn and that if I take them upon departure the costs for those items will be charged to my guest room.

**Responsibility for Claims.** You are responsible for all claims, damages, liabilities, losses, fines, penalties, costs and expenses ("Claims"), including property damage and personal injury, arising out of, caused by, or resulting from your dog's presence at Abeja Inn and Winery. You agree that we may charge your guest room for any such damages.

**Indemnity.** You will indemnify, defend, and hold Abeja Winery and Inn, Columbia Hospitality, Inc., their affiliates and subsidiaries and each of their owners, members, directors, officers, employees, contractors and agents from and against any and all Claims arising out of, caused by, or resulting from your pet's presence at Abeja.

**ADA Commitment.** We are committed to complying with the Americans with Disabilities Act and nothing in this policy is intended to affect our commitment and our legal obligation to do so.
